Dues or contributions to CAMB are not tax deductible as charitable contributions for federal tax purposes. However, membership dues payments may be deductible by members as an ordinary and necessary business expense. A portion of dues, however, is not deductible as an ordinary and necessary expense to the extent that CAMB engages in lobbying. Dues or contributions to CAMB and NAMB are not tax deductible as charitable contributions for federal tax purposes. The nondeductible portion of your 2008 dues for CAMB is estimated to be ten (10) percent. NAMB estimates that 39 percent of your 2008 NAMB dues is not deductible. Federal law prohibits the deduction from your taxes that portion of member dues allocated to federal lobbying activities.
