**CAMP memberships are individual memberships owned by the applicant, except the Broker/Banker Company and Statewide Affiliate Industry Partner category.** CAMP's membership is for one year from the date dues are received and is renewable annually. With this application and payment, you are applying for membership in CAMP, which includes membership in your selected Chapter and may also include the National Association of Mortgage Brokers (NAMB).

*Dues or contributions to CAMP are not tax deductible as charitable contributions for federal tax purposes. However, membership dues payments may be deductible by members as an ordinary and necessary business expense. A portion of dues, however, is not deductible as an ordinary and necessary expense to the extent that CAMP engages in lobbying. Dues or contributions to CAMP and NAMB are not tax deductible as charitable contributions for federal tax purposes. The nondeductible portion of your 2010 dues for CAMP is estimated to be ten (10) percent. NAMB estimates that 39 percent of your 2010 NAMB dues is not deductible. Federal law prohibits the deduction from your taxes that portion of member dues allocated to federal lobbying activities.*
